

## Announcement of Chumphon Primary Educational Service Area Office 2 Subject: "Declaration of Integrity in Public Administration of Chumphon Primary Educational Service Area Office 2"

Chumphon Primary Educational Service Area Office 2 places value on integrity and transparency in public administration, according to the policy (delivered by Prime Minister, General Prayut Chan-O-cha) on promoting good governance in administration and prevention of corruption and misconduct in the public sector by the Code of Conduct of Civil Servants B.E. 2552 (2009), Integrity and Transparency Assessment (ITA) of Office of the National Anti-Corruption Commission (NACC) and Office of Public Sector Anti-Corruption Commission (PACC).

I, on behalf of an executive of Chumphon Primary Educational Service Area Office 2, shall encourage all officials and personnel to work with morality, transparency, efficiency and productivity, shall maintain the interests of the public sector, and shall impartially ensure fairness and equality to the people.

I hereby express my intention to all civil servants that I shall perform my administrative duties in preventing and combating corruption in the public sector with consciousness and awareness of my responsibilities. I shall perform my duties with knowledge, ability, integrity and be conscious of what is wrong, what should be done, what should be abstained, so that the work is free of damage and reach the maximum benefit by adhering to good corporate governance and I shall take a clear stand against all forms of corruption for the most benefit of the people and the nation.

On behalf of all levels of executive of Chumphon Primary Educational Service Area Office 2, I would like to announce the intention to operate with integrity in accordance with good governance, transparency and accountability in order to boost confidence in our society on Chumphon Primary Educational Service Area Office 2's intention to anti-corruption of all forms and commitment to make our office a white government agency. Actions are as follows.

1. Strictly comply with all laws, rules and regulations, as well as encourage all personnel to work in accordance with the laws, rules and regulations.

Instill and raise awareness of anti-corruption, separate personal interests from the common interest, instill a sense of morality and anti-corruption in the unit, as well as build a strong and effective internal counterbalance to ensure that the personnel of Chumphon Primary Educational Service Area Office 2 recognize the bad effects and the threat of corruption to the government and the nation, and to create a culture of anti-corruption in the organization.
- 3. Do not accept corrupt behavior and do not tolerate corruption that results in social sanction. Create a personnel sense of shame or fear to commit fraud.
- 4. Instill awareness to the students in the institution under Chumphon Primary Educational Service Area Office 2 to be aware of bad effects and combat corruption.

- 5.1 Coordinating and cooperating in the implementation of the National Strategy for the Prevention and Suppression of Corruption, Phase 3 (2017-2021)
- 5.2 Jointly collaborating all units and personnel under Chumphon Primary Educational Service Area Office 2 to build a network of anti-corruption
- 5.3 Jointly conducting researches and studies and gathering knowledge on anti-corruption
- 5.4 Providing knowledge about the National Strategy for the Prevention and Suppression of Corruption, Phase 3 (2017-2021). In particular, the ethical and moral guidelines for all levels of management and personnel under Chumphon Primary Educational Service Area Office 2 to build awareness and participation in campaigning for youth, parents and the general public to participate in anti-corruption activities and to participate as a network to prevent and combat corruption
- 5.5 Developing communication channels for dissemination and public relations to support the operation of the Anti-Corruption Cooperation Network.
- 5.6 Jointly undertaking any other actions on anti-corruption of all forms in a full capacity
